- f) The headings and sub-headings do not form part of this privacy policy

Scope of this privacy policy

- 3) This privacy policy applies only to the actions of Heidi Brookshaw Racing and Users with respect to this website. It does not extend to any websites that can be accessed from this website including, but not limited to, any links we may provide to social media websites.

Data that is collected automatically

- 8) To the extent that you access the website, we will collect your data automatically, for example:
 - a) We automatically collect some information about your visit to the website.  - b) We will collect your data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies and how we use them on the website, see the section below, headed 'cookies'

- 9) Any or all of the above data may be required by us from time to time in order to provide you with the best possible experience when using our website. Specifically, data may be used by us for the following reasons:

- 11) Heidi Brookshaw Racing is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our products and services to you. Your data is

stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall

Data retention

- 14) Even if we delete your data, it may persist on backup or archival media for legal, tax or regulatory purposes

Your rights

- 15) You have the following rights in relation to your data:
- a) **Right to access** – the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is 'manifestly unfounded or excessive' Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
